

**Western Lake Erie Basin Coordinated Management Committee  
Planning Meeting Minutes  
July 18, 2012**

**Attendees:** Jason Lewis (Ottawa NWR), Dave Zenk (Metro Parks of the Toledo Area), Scott Butterworth (ODOW), Ron Huffman (Ottawa NWR), Eddy Pausch (Ottawa NWR), John Simpson (Winous Point)

**Purpose:** Increase cooperation and coordination of land management efforts in the Western Lake Erie Basin.

**Area Extent:** Ottawa, Lucas, Erie, Sandusky, and Wood Counties. Area of extent may be revised based on priority habitat for preservation or restoration as determined by The Nature Conservancy research.

**Goals and Objectives:**

- 1) Increase resource sharing among partners.
- 2) Promote information exchange among partners and technical experts on management strategies, conservation priorities, and permit processing.
- 3) Manage WLEB wetland habitats across partnership boundaries to ensure a diversity of habitat types available on the landscape.
  - a. Inventory existing protected wetland habitat in the W. Lake Erie Basin to identify habitat types and area extents present in the landscape
  - b. Rank priority areas for protection within the Western Lake Erie Basin
  - c. Develop a management plan for Western Lake Erie Basin wetlands which identifies Best Management Practices
- 4) Coordinate efforts to pursue funding opportunities, ensuring highest priority projects (as determined by the WLEB Committee) are most competitive
- 5) Promote the economic benefits of conservation to the local community.

- Amanda Conover will contact the Green Ribbon Initiative to discuss the development of their management plan, to possibly serve as a model for this committee.
